Bylaws Article XI Section 6 – The presence at any meeting of members entitled to cast fifty percent (50%) of the votes of membership, represented in person or by proxy, shall constitute a quorum at meetings of members except as otherwise provided in the Declaration, the Articles or these Bylaws. If, however, a quorum shall not be present or represented at any meeting of the members, the members present in person or represented by proxy shall have power to adjourn the meeting immediately after such adjournment (without necessity for additional notices to members) to reconvene a meeting of members, at which a quorum shall consist of fifty percent (50%) of the quorum required at the prior meeting, and if a quorum is present, any business may be transacted which might have been transacted at the meeting originally notified; provided that, no such second meeting shall be more than sixty (60) days following the first meeting.
